6:30 P.M – Inmate A. Green#146005 can be seen standing in his doorway watching t.v.

6:42:52 PM -Inmate Green is fishing to cell 45 in 8 barracks

7:01:33 P.M. – Cpl. Tims enters the barracks and is passing the phone in 8 barracks security round is made

7:13 P.M. - Inmate Green is pacing around his cell

7:32:10 P.M. – Sgt. Brewer and Cpl. Kelly enter the barrack. Sgt. Brewer makes a round

7:44:13 P.M.- Cpl. Tims brings in the laundry cart.

7:49:43 P.M. – Cpl. Kelly enters the barracks makes round on the first and third tier but not the second tier (***incomplete round***)

7:58:38 P.M. – Cpl. Kelly exits the barracks

8:05:07 P.M. – Cpl. Kelly enters the barracks

8:08:55 P.M. – Cpl. Kelly exits the barracks

8:11:14 P.M. – Inmate Green appears to be reading a book

8:11:46 P.M.- Cpl. Kelly exits the barracks

8:12:37 P.M. – Cpl. Kelly brings in the mop bucket

8:16:10 P.M. – Inmate Green came back to the cell door and appears to be watching t.v.

8:21 P.M. – Cpl. Tims appears to pick up laundry bags while Cpl Kelly continues to clean the shower

8:29:04 P.M. – Cp. Kelly and Cpl. Tims start showers in 8 barracks

8:43:25 P. M.- After placing three Inmates in the shower Cpl. Tims and Cpl. Kelly exit

8:53:29 P.M. – Cpl. Kelly enters barracks and sits on the steps

8:56:41 P.M. – Inmate Green starts fishing, gets the state phone (securus does not show a call being made)

8:56:46 P.M. – Cpl. Tims enter the barracks and they start to take Inmates out of the shower

9:05 P.M. – Inmate Green continues to fish

9:08:21 P.M. – Showers being conducted by Cpl. Tims and Kelly, and Inmate Green continues to fish

9:13:20 P.M. – Inmate Green standing at his cell door watching t.v.

9:27 P.M. – Inmate Green appears to lay down on his bed

9:28:20 P.M. – Inmate Green gets up and starts to pace around his cell

9:38 P.M. – Inmate Green sits back down on his bed

9:49:43 P.M. - Inmate Green returns to his cell door

9:51:34 P.M. – Inmate Green lays back down on his bed

9:52:04 P.M. – Cpl. Kelly and Tims enters 8 barracks and sits on the stairs

9:57:52 P.M. – Cpl. Kelly and Tims exit barracks

10:05 P.M. – Inmate Green stands on what appears to be an exercise bag and appears to get a sheet and starts tying it together

10:08 P.M. – Inmate Green comes back to the door, and continues to braid on the white sheet

10:12:46 P.M. – Inmate Green's light goes out

10:13:40 P.M. – Inmate Green can be seen standing in the doorway

10:15:02 P.M. – There is no visual of Inmate Green

10:18:46 P.M. – Inmate Green can be seen with his weight bag

10:20:47 P.M. – Inmate Green can be seen walking around and then the visual is lost

10:22:37 P.M. – Sgt. Brewer enters the barracks

10:23:30 P.M. – Sgt. Brewer exits no round made

10:26 P.M. – Inmate Green can be seen in his cell, and then a blanket goes up

10:27:15 P.M.- Inmate Green can be seen tying the sheet around the bars

10:29:37 P.M. – Cpl. Tims and Cpl. Kelly exits barracks

10:31:45 P.M. – Cpl. Kelly enters the barracks and he and the Porter start to gather laundry bags

10:39 P.M. – Cpl. Kelly can be seen passing laundry bags out

10:44:59 P.M. – Cpl. Kelly exits barracks and Inmate S. Stuckey#169933 enters the bull pen

10:54:33 P.M. – Cpl. Tims and Inmate Stuckey enter 8 barracks and start to pass out laundry bad

11:05:16 P.M. – Cpl. Kelly enter the barracks and starts to pass out laundry bags they make a pass by cell 48 that solely housed Inmate Green

11:13:50 P.M. – Cpl. Kelly stops at cell 48 and appears to drop the laundry bag in front of the cell. He picks it up and places it on the bars.

11:16:59 P.M. – Cpl. Kelly exits barracks

12:27:22 P.M. – Cpl. Tims enters the barracks and goes to cell 1 that solely house Inmate Michael Williams#156130

12:31:50 A.M. – Cpl. Tims exits 8 barracks

12:47:01 A.M. – Nurse Whitmore is walked by Cpl. Tims

12:48:37 A.M. – Cpl. Tims and Nurse Whitmore exits 8 barracks

1:37:02 A.M. – No movement at cell 8-48

2:37:30 A.M. – Cpl. Kelly comes into the barracks a hand a roll of tissue to cell 7 that solely house Inmate A. McCullough#131910

2:38:21 A.M. – Cpl. Kelly exits the barracks. There is no movement at cell 8-48

3:37:00 A.M. - No Movement cell 48

4:03:15 A.M. – Cpl. Kelly enters 8 barracks and appears to give juice to the first tier and exits at approximately 4:06:30 A.M.

4:08:01 A.M. Cpl. Kelly and Sgt. Brewer enters 8 barracks to feed breakfast

4:15:59 A.M. – Cpl. Kelly arrives at cell 48 to pour juice and pulls back a blanket that is partially covering the cell door. Cpl. Kelly calls down for Sgt. Brewer who arrives at cell 48 at approximately 4:17”06 A.M.

4:17:14 A.M. – Lt. Freeman runs into barracks 8 and goes up to cell 48 at approximately 4:17:43 A.M.

4:18:12 A.M – Cell 48 is opened, and the light is turned on

4:18:23 A.M – Cpt. E. Litzsey arrives in 8 barracks

4:27:53 A.M. – Nurse Culp arrives in 8 barracks and goes to cell 48

4:39:03 A.M. – Gurney arrives in 8 barracks

4:56:19 A.M. – Inmate Greens body is taken from 8 barracks to the infirmary, and the cell is secured, and an Officer is posted outside the cell
